Please find below the full list of members of the AGCPC as reconstituted.

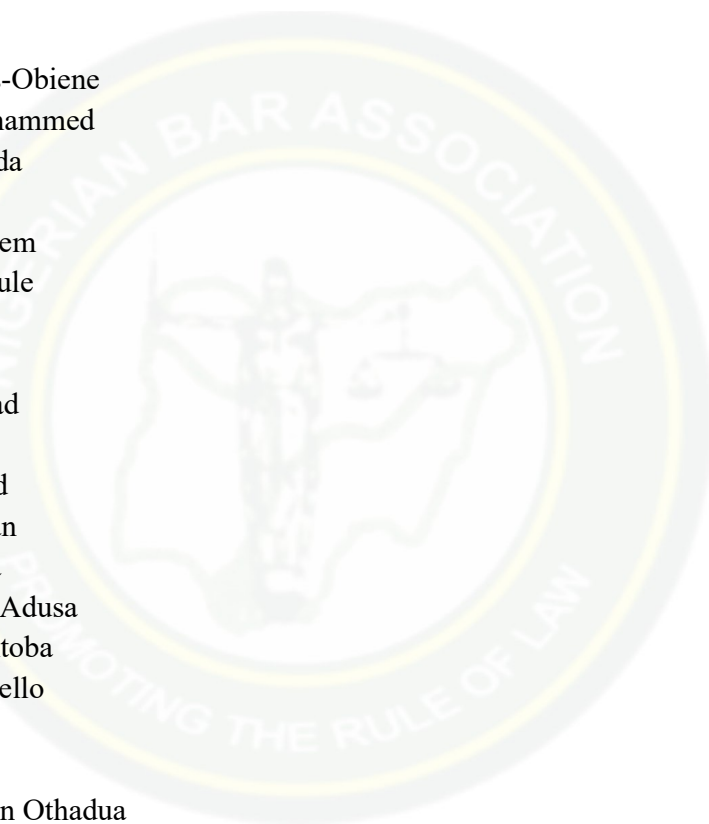
