

scrabble player. I serve in my parish as a lay reader of the Catholic Church. I am happily married to Onyinye and we are blessed with 3 lovely boyz.



Upon careful consideration and reflections, coupled with wide and meaningful consultations across a broad spectrum, I Reginald Iheanyichukwu Ugwuadu, Esq. hereby present myself as a candidate in the 2024 NBA national elections for the of fice of first Vice President.

WHAT HAS REGINALD UGWUADU GOT TO OFFER?

I intend to serve the Nigerian Bar Association in line with the provisions of S. 9(5)(b)(i)-(iv) of the Constitution of the Nigerian Bar Association 2021.

- 1. In line with the constitutional provision which requires the first vice president to act in the stead of the President as occasion demands or as directed by the President or NEC, I shall bring to bear my inter personal skills and team player spirit in ensuring the smooth flow of the administration, through conscious efforts to build a cohesive and all inclusive team, with the common purpose of upholding the tenets of the Association and and serving the interest of the members and the public at large. This will no doubt ease the burden on the President and reduce to the barest minimum, friction between the president and other members of the Executive committee.
- 2. As regards the duties of supervising NBA branches assigned to the office of the first vice president by the president or NEC, proactive steps will be taken to ensure that such branches under my watch feel the impact of the Association and benefit from programs and schemes set up by the Association. To achieve this, a WhatsApp platform will be set up comprising of all the chairmen under the zone being supervised, to ensure a smooth and realtime flow of information and shorten reaction time in the event of an emergency.
- 3. While, the constitution allows the First Vice President to act as liaison between designated branches and president/NEC to encourage the establishment of new branches, in reality my main focus will be enhancing the viability of our branches, with a primary focus on the welfare of members and the impact of the activities of the NBA on the citizenry. To this end I will in conjunction with the Exco of each of the branches under my supervision, encourage the Branches to cascade and replicate the laudable programs at the National level for the interest of its member. In this regard, the Human Rights committee in the Branches will be encouraged to be more proactive and be up and doing in the defence of the rights of our members and the public, and to check the excesses of security agents, who might decide to be overzealous.



- 4..Furthermore, regarding the welfare and earnings of our members, the various branches will be encouraged to set up taskforces to ensure compliance with the provisions of the Legal Practitioners Remuneration (for Business, Legal Service and Representation) Order, 2023 and bring erring members to justice.
- 5. Flowing from this, branches will be encouraged to embark on projects and programs that will impact directly and positively on its members in line with the immediate need of that locality. This will in no small measure increase the interest of members to participate in the activities of the NBA at the branch level.
- 6. Final, the first vice president shall be readily available to undertake any and all task which the president and or NEC, may from time to time, direct to be done and periodic reports of all assignments, shall be presented to the National Executive Council and National Executive Committee.

I af firm that I shall willingly deploy my time, energy and resources to serve the Nigerian Bar Association and collaborate with the president and other members of the National Executive Committee to deliver premium service to our members, even as we deepen the tenets of the rule of law.
